GRANTS UNDER FAMILY PLANNING PROGRAM

Since the initiation of the Family Planning Program by the Minister of National Health and Welfare on May 5, 1971 (a) to what organizations were grants made and what was the amount in each case (b) what organizations have been refused grants and what was the amount of money requested in each case (c) what organizations have applications for grants still pending and what amounts of money are being requested in each case?

Hon. John C. Munro (Minister of National Health and Welfare): 1. Projects received and assisted in the field of family planning are as follows: National Health Grant Program: Family planning Federation of Canada, \$60,000; Service de Régulation des Naissances, \$25,000.

National Welfare Grant Program: Centre de Planning Familial du Québec Inc. Montréal, \$500; Ministère des Affaires Sociales du Québec, \$37,670; Planned Parenthood Society of Hamilton, \$17,540; United Community Services of the Greater Vancouver Area, \$6,597; Family Planning Federation of Canada, \$40,000.

Family Planning Grant Program: Family Planning Federation of Canada, \$385,000; Service de Régulation des Naissances, \$40,000.
