CALL FOR STEPS TO RESTORE CONFIDENCE—MOTION UNDER S.O. 43

The dollar has dropped to its lowest level in relation to the American dollar in over a year, despite massive government intervention in the money markets. ## UNEMPLOYMENT INSURANCE

FLEXIBILITY IN APPLICATION OF MATERNITY BENEFITS—MOTION UNDER S.O. 43

**Mr. Walter McLean (Waterloo):** Madam Speaker, I rise under the provisions of Standing Order 43. In light of the commitment of the Minister of Employment and Immigration (Mr. Axworthy) to amend the so-called magic ten rule, which presently operates as a prerequisite to qualify for maternity benefits under unemployment insurance, and in light of the demeaning effect of this rule and its rigid application, as seen in the case of Mrs. Katherine Edwards of Kitchener, Waterloo, who has been denied maternity benefits because she is 53 minutes short of the mandatory ten-week insurable employment period—a decision taken without regard for the significant overtime she worked—I move, seconded by the hon. member for Saskatoon West (Mr. Hnatyshyn):

That this House asks the minister to instruct his officials to be flexible and sensitive in such borderline cases until changes to maternity benefit legislation are enacted, as promised.
