prohibit its import into Canada. We intend to enforce the law as it presently exists. With regard to the future law, I will, of course, be consulting with my colleagues, the Minister of Justice and the Minister of Finance.

# REQUEST FOR POSTPONEMENT OF PROGRAM AS APPLIED TO SMALL BUSINESS

Mr. Bill Domm (Peterborough): Madam Speaker, my question is for the Minister of State for Small Businesses and Tourism. It stems from two notices which arrived in my office this morning. One is a transcript of one sentence from the executive director of the Metric Commission in which he says the members in the sector dealing with scales in the retail food industry at a scheduled meeting for conversion of scales had, and I quote:

In light of the minister's answer in the House a week ago that he would take into consideration the submissions of the Canadian Federation of Retail Grocers and the major corporate chains, and now that he has the Metric Commission opposed to the implementation of metric at this time, will the minister finally represent the small business sector in Canada and go before cabinet to delay forcing metric conversion, making Canadian measurement illegal in January, 1982?
