## FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF

Mr. David Orlikow (Winnipeg North): Mr. Speaker, I have the honour to present a number of petitions signed by residents of Winnipeg, mostly from my own constituency, who believe that the family allowance deindexation will not be offset by changes to the child tax credit and that the poorest families will be worse off by 1990 as they fall further and further behind. The petitioners humbly pray and call upon the House of Commons to reinstate full indexation of the universal family allowance and rescind the unfair tax increases.

Mr. Les Benjamin (Regina West): Mr. Speaker, I have three petitions, two of them on the same subject. One petition is from the city of Regina and one from The Battlefords-Meadow Lake area of Saskatchewan. These more than 200 petitioners humbly pray and call upon Parliament to maintain the full indexing of the family allowance program and to rescind all the unfair tax increases in the Budget.
