comparable. In other words, the fiscal efforts being made in those provinces are much greater than those being made in other provinces. In Alberta, which has substantial problems, there is no sales tax at all.

I remind Members of the House of the Constitution which was passed in 1981 and came into force a year later. Section 34(2) reads:

Parliament and the Government of Canada are committed to the principle of making equalization payments to ensure that provincial governments have sufficient revenues to provide reasonably comparable levels of public services at reasonably comparable levels of taxation.

Mr. Speaker, as the Quebec Minister of Finance just wrote to the Minister of Finance of Canada, here in the House, that is no longer the case for Quebec or any of the other provinces that are disadvantaged. And in fact, as Mr. Lévesque said in his letter, Quebec cannot afford a level of public services reasonably comparable to that of the other provinces unless it places a tax burden on its taxpayers that is far heavier than the average level of taxation in Canada, or else goes deeper into debt.

Mr. Speaker, the Quebec Minister of Finance believes that Quebec will owe \$1.4 billion more in 1985-86 under the existing equalization formula. It is a fact that the existing formula which the Minister of Finance of Canada wants to maintain does not live up to the solemn commitment contained in the Canadian Constitution. These are the facts. We are creating two classes of provinces in Canada, the wealthy provinces and the others, those which receive equalization payments and cannot provide substantially the same level of Government services because of the weaknesses of the existing equalization system.

Mr. Speaker, we are going to make specific comments on the bill, but generally speaking, the Government has forgotten the commitment made by the Conservatives during the 1984 electoral campaign to work for national reconciliation. They are no longer working to reach this goal and this is a serious mistake. It shows a marked lack of concern.

They feel that the proposed measure will unfairly hurt those Canadians whose health needs require the purchase of prescription drugs on an ongoing basis. They, therefore, humbly pray and call upon Parliament to reject these proposals which will increase prescription drug prices for Canadians.
