

Order Paper Questions

In so far as the Department of National Health and Welfare is concerned: 1. Results of a study carried out for the Health Protection Branch by a consulting laboratory indicated no adverse effects to housewives using a large number of aerosol products for a period of six weeks. These results were published in the Canadian Medical Association Journal in July 1974.

2. An interdepartmental ad hoc group of experts is studying all facets of aerosol products containing F 11 and F 12 fluorocarbons. Industry has agreed to decrease by one-half their usage of such materials during 1977, and all but essential uses of fluorocarbons as aerosol propellants will be phased out by December 1978.

As of December 31 (a) 1968 (b) 1976, what was the number of federal employees engaged to inspect coal mines?

Mr. Ralph E. Goodale (Parliamentary Secretary to President of the Privy Council): In so far as the Department of Indian Affairs and Northern Development is concerned: (a) Nil. (b) 3.

In so far as the Department of Labour is concerned: (a) Mine inspections were carried out for Labour Canada under contract with department of mines of Nova Scotia. (b) Four federal government employees were engaged in inspection of coal mines of Cape Breton Development Corporation. In addition, there were: one chief inspector, one laboratory technician and two support employees. Notwithstanding the above reply, most mining activities in Canada are within provincial jurisdiction.
