SMASHED WORLD'S RECORD.

NEW YORK, Oct. 16.—D. C. Johnson's Rosenb, carrying 125 pounds, created a new world's record for seven furlongs for circular and straight away courses, when he won the fifth race at Belmont Park today. He stopped the distance in the fastest time ever made on an American race course—1:22. When he finished and the phenomenal time was hung out by the official timer, the big crowd gave the great sprinter a rousing cheer which continued for several minutes in spite of the fact that they were unable to bet on him at the prohibitive odds of 1 to 80. Johnson and Frank Farrell are reported to have won over \$2,000 on his victory, as they bet that the son of Benbow—Rose Leaf—would run faster than 1:23. Fourteen horses were carded to go in this event, but they were all scratched except Benbow, and it was after the withdrawal that it was decided to send Rosenb against time. Rosenb ran the first furlong in 12 seconds, passed the quarter in 23 1/4, and the three-

eighths in 35 1/4. Around the long upper turn the horse continued in faultless style and finished by the half-mile pole in 46 1/4. When he turned into the stretch the high wind was behind him and he cantered to the three-quarter mark in 1:10 3/4. He was now beginning to show signs of tiring and Shaw took no chances with him and rode Rosenb out to flash under the wire a winner in 1:22. The best previous time was 1:24 1/4, held by the straight-away record was established by Della B. of 1:24.

JOHN'S Nfld., Oct. 16.—Premier Bond in an interview today, declared that the statements of the American press to the effect that the colony was a party to the modus vivendi is a tissue of falsehoods. The premier asserts that the colony has conceived nothing, that she insisted upon her rights and had besought the imperial government to support them. The modus vivendi, he says, was concluded against the protest of the colony of Newfoundland and the government did not sanction any of the concessions granted Americans, but had exhausted every resource it could command in opposing the agreement, which attitude of firm opposition it does not intend to abandon, regarding the measure as derogatory to colonial rights and laws.
