

MATHESON, JOSEPH. (*Richmond.*)

Parents, natives of Ross-shire, Scot., settled in Cape Breton, in 1819. B. at Grand River, N.S., May 1833. M., 22 March, 1864, Maria S., dau. of Josiah Hooper, formerly of Bristol, Eng., and M.P.P. for Richmond from 1867 to 1871. Is a merchant, and was Postmaster Lower L' Ardoise from 1866 to 1886. First returned to Ho. of Assem. at last g.e. A Liberal.—*Lower L' Ardoise, N.S.*

McCALL JEFFREY. (*Pictou.*)

B. at Guysborough, N.S., 16 June, 1833. Is a ship-owner. First returned to Ho. of Assem. at last g.e. A Radical and a Repealer.—*New Glasgow, N.S.*

McCoy, WILLIAM FREDERICK, Q.C. (*Shelburne.*)

B. at Lysrian, in the Co. of Longford, Irel., 15 May, 1840, and came to N.S. when eight years of age. Ed. at Sackville Academy, N.B. M., 14 July, 1868, to Maud L., dau. of Robert P. Woodill, Esq., merchant, Shelburne. Called to the Bar, N.S., in 1864, and appointed a Q.C. 11 Oct., 1880. Practised his profession in Shelburne for nine years, when he removed to Halifax, where he now practices. Was elected an Alderman for the city of Halifax in 1881. Offered the position of Attorney-General in the Liberal Govt., formed 3 Aug., 1882, but declined, considering that his colleague had a prior claim to a seat in the Govt. An unsuccessful candidate for present seat in Leg. Assem. at g.e. 1878. First returned to Ho. of Assem. at g.e. 1882 and re-elected at last g.e. A Liberal and a strong Repealer.—*Halifax, N.S.*

MACGILLIVRAY, Hon. ANGUS. (*Antigonish.*)

Grandfather Angus MacGillivray emigrated from Arisaig, Inverness-shire, Scot. B. at Bailey's Brook, Pictou Co., N.S., 22 Jan., 1842. Removed with parents when quite young to Antigonish. M., 5 Feb., 1878, Maggie, dau. of the late Alexander McIntosh, Esq., Antigonish (she d. 8 Sept., 1879). Secondly, 15 July, 1884, Miss Doherty, of N.Y. Ed. at St. François Xavier Coll. there. Called to the Bar of N.S. 22 July, 1874. Is a partner of the law firm of MacGillivray & Chisholm. First returned to House of Assem. by acclamation at g.e. 1878, and re-elected at g.e. 1882, and again at last g.e. Was Speaker of the House from Feb., 1883, until the dissolution of the Assembly. Apptd. a mem. of the Ex. Council
