## PROCEEDINGS EDIT GRAND LEGION

## ANNUAL REPORT

" the Grand Medical Exartier, S. L. of C. for Fiscal Year -91.

STRS AND COMRADES :-I herewith submit my Eighth Annual Report, which exhibits a volume of busine ione in excess of any previous year.

The number of Applications, Beneficiary and Endowment, received and acted upon by me during the past year reached the total of 1376; being a gain of 132 over the the preceding year. Of this number 1306 have been approved, 56 rejected, and 14 of those sent back for fuller information, have not, at the closing of this Report, been returned to me.

The total Beneficiary Applications received by me to the close of Seventh Annual Report was 2868 ; adding thereto 612 received during the past year, the number reaches 3480.

The Endowment Department has only been two years in existence ; the Applications received to close of last Report num ber 378, to which add 764, those of the closing year, and we get a total of 1142.

The rejected Applications are classified according to the cause thereof.



ENDOWMENT DEPARTMENT.

One year ago I stated in my report that I was fully satisfied that the Endowment was destined to become a prominent Department of this Order. The progress made since then has not only assured me that my predictions were correct, but exceeded my expectations. There are at the present date 1009 members in this Department, 608 of whom were received during the past year.

The 22 assessments, which have been collected with the accrued interest added thereto, already amount to the handsome sum of \$14,512.00, which is deposited in the Bank of Toronto to the credit of the Endowment Fund of the Grand Legion of Ontario, Select Knights of Canada.

While every Comrade has a perfect right. to his private opinion regarding the feasibility of the Endowment scheme, and may accept or reject the benefits which that department offers him, still I regret that some few of our old Beneficiary members, who are opposed to the Endowment, have (perhaps unintentionally) been injuring the Order by stating that the Endowment was being boomed at the expense of the Beneficiary department. Being fully conversant with the greater part of the work which has been done in both departments, I can assure this Grand body and the Order generally that the Endowment has not only largely benefited the Beneficiary Department during the past year, but very materially increased the General Fund of the Grand Legion.

To my certain knowledge nearly 100 Beneficiary Certificates were issued to Endowment members who would not have joined the Order but for the benefits offered here in the Endowment Department.
