Accounts of the anniversary meetings in London, which do honor to the philanthropy of the British nation, have reached us. They do not exhibit any falling off in the firmness of their principles.

The meeting of the British and Foreign Anti-Slavery Society, on the 10th inst., was attended by 2000 persons, and the Rev. Mr. F. Douglass presided.

The affairs of the Church Missionary Society were equally prosperous. The receipts for the year were 205,554, and fifty-two new Associations had been formed.
