**Hon. E. D. As I explained last week on May 3 and 4, these documents form the basis for the statement of material prepared by the director, which statement, together with the documents, is now before the commission. The commission's report will be made in due course and will contain reference to such of the documents as the commission deems appropriate, and that report will be made public.
