JURISDICTION OVER WHEAT BOARD
AND GRAIN COMMISSION

Mr. J. E. Pascoe (Moose Jaw-Lake Centre): This is a question that I wished to put to the Minister of Agriculture as a supplementary question yesterday but I failed to attract the attention of the Chair. I trust, Mr. Speaker, you will say it is still in order.

Replying to an earlier question of mine in connection with a board of grain commissioners hearing on grain handling charges, the minister stated that under the provisions of section 17 of the Canada Grain Act every regulation established by the board must be transmitted to his department. This means that the board of grain commissioners comes under the jurisdiction of the Minister of Agriculture while the Canadian wheat board comes under the jurisdiction of the Minister of Trade and Commerce.

Does the minister consider this arrangement to be in the best interest of agriculture?

Hon. Harry W. Hays (Minister of Agriculture): Yes, Mr. Speaker.
