## UNITED NATIONS

SOUTH-WEST AFRICA-CANADIAN POSITION AT EMERGENCY SESSION

On the orders of the day:

Mr. Howard Johnston (Okanagan-Revelstoke): Mr. Speaker, my question is to the Prime Minister. Could the Prime Minister give any indication to this house of the course to be followed by Canada at the emergency session of the United Nations to deal with the question of South-West Africa, which opens in New York today.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, the special assembly which has been called to consider this and one other question is, as my hon. friend knows, meeting today. The first item on the agenda is to the one mentioned by my hon. friend, consideration of a report from the committee that has been discussing this question in the light of the assembly resolution of last autumn.

I understand three resolutions were submitted to that committee, and the committee has not made a unanimous report. Two of the resolutions provided for the territory to be administered or supervised by the security council because of the alleged failure of the mandate and the mandatory country; the third was a resolution sponsored by Canada, and I think two other countries, providing for-I am just relying on memory now-an inspection of the situation by the United Nations Secretary General or a representative. That is the resolution which the Canadian delegate to the special assembly will be supporting.
