## FINANCE

IMPLEMENTATION OF TARIFF CHANGES FOLLOWING GENEVA CONFERENCE

On the orders of the day:

Mr. H. W. Danforth (Kent (Ont.)): I wish to direct a question to the Minister of Finance. Because it has been indicated that there may be a release of information in July regarding the tariff changes made at Geneva, and because of the importance of the matter, may I ask the minister whether legislation will be required before any of these changes are implemented?

Hon. Mitchell Sharp (Minister of Finance): Mr. Speaker, some of the tariff changes that have been negotiated will not require parliamentary approval because parliament has already authorized the government to make reductions in certain tariffs. Others will require legislation because they involve reclassifications. In other matters, for example, as the change in the anti-dumping laws, parliamentary action will be required. In any event, Mr. Speaker, the changes would not come into effect until parliament had been given ample opportunity to debate the matter.
