## FORTHCOMING VISIT BY PRESIDENT NIXON—POSSIBLE ARRANGEMENT TO ADDRESS SENATE AND HOUSE

**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, I do not want to disturb the Prime Minister in any way from his absorption in reading, but I would like to ask a question which I hope he will not regard as controversial or upsetting to his equanimity. Has the government extended an invitation to the President of the United States on the occasion of his prospective visit to Ottawa to speak to the House of Commons and the Senate, as was the case during my period as prime minister when we had visits from President Eisenhower and President Kennedy?

**Right Hon. P. E. Trudeau (Prime Minister):** The arrangements between the two countries are not final yet, and I think it would be improper for me to announce them in a unilateral fashion. However, as soon as possible, we will announce the program for the president's visit in Washington and in Ottawa at the same time.

**Mr. Diefenbaker:** It is not a question of unilateral revelation at all. The Prime Minister does not trust this House because he reads.

**Some hon. Members:** Oh, oh.

**Mr. Diefenbaker:** He reads with prima donnal arrogance.

**Mr. Diefenbaker:** It is a disgrace to the House of Commons.
