Since there are many communities throughout Canada which have disabled people, and there are people in those areas who would like to form voluntary organizations to assist these unfortunate people, is her Department providing any assistance, physical or financial, to assist in the formation of such organizations, since a check with some of the officials in her Department has produced negative results?
