3. What are Canada's stated NATO commitments in relation to Maritime Command?

Mr. Robert Wenman (Parliamentary Secretary to Minister of National Defence): 1. Defence expenditures devoted to Maritime Forces for the fiscal years 1980-81 through 1983-84 are as follows:

1980-81-\$1,221,495,000

1981-82-\$1,144,034,000

1982-83-\$1,010,260,000

1983-84-\$1.259.081.000

2. Canada maintains maritime forces capable of roles in the defence of Canada, defence of North America, NATO collective defence, and international peacekeeping. These forces comprise the following major units: 23 destroyers, three submarines, three underway replenishment ships, one diving support ship, three maritime patrol aircraft squadrons, two antisubmarine helicopter squadrons and one medium range air reconnaissance squadron.

3. Canada has indicated that all of the above maritime forces would be available in times of hostilities for NATO operations.
