Is the government aware of a retirement group inside Canada Post known as the Heritage Club and, if so (a) what is the ratio between members of the club who are management retirees and those who were regular employees of Canada Post (b) is there a board of directors of the club and, if so, are they paid and, if so, by whom (c) who pays the cost of club events?

Hon. Harvie Andre (Minister of State and Leader of the Government in the House of Commons): (a) Actually, there is 21,428 members to the Heritage Club. The breakdown is as follows:

Active members (25 years or more of service) 1,466

Retirees 19,962
