

Of Ruth Rosenberg, of Montreal, Quebec; praying for the passing of an Act to declare her marriage with David Lewis Rosenberg, of Montreal, Quebec, now living in Vancouver, British Columbia, to be dissolved, and that she be divorced from him.—*Mr. MacNicol*.

Of Joan Marguerite Loggie, of Martin, Salisbury, Wiltshire, England; praying for the passing of an Act to declare her marriage with John Miller Loggie, formerly of Toronto, Ontario, now residing in Montreal, Quebec, to be dissolved, and that she be divorced from him.—*Mr. Geary*.

Of Eileen Sybil Wolfe, of Montreal, Quebec; praying for the passing of an Act to declare her marriage with Gerald Wolfe, of Montreal, Quebec, to be dissolved, and that she be divorced from him.—*Mr. Factor*.

Of Ellen Jane Easton, of Montreal, Quebec; praying for the passing of an Act to declare her marriage with Henry Arthur Graham, of Montreal, Quebec, to be dissolved, and that she be divorced from him.—*Mr. Bell (St. Antoine)*.

Of Carl Vohwinkel, of Montreal, Quebec; praying for the passing of an Act to declare his marriage with Augusta Victoria Sporleder, of Halifax, Nova Scotia, to be dissolved, and that he be divorced from her.—*Mr. Bell (St. Antoine)*.

Of Guaranty Trust Company of Canada; praying for the passing of an Act to amend its Act of Incorporation by increasing the capital stock.—*Mr. Robinson*.

Mr. Cahan, a Member of the King's Privy Council, presented,—Return to an Address to His Excellency the Governor General of September 22, 1930, for a copy of all correspondence and documents of all kinds exchanged between any Member of the Government of Ontario and any Member of the Federal Government of Canada with respect to: (1) The construction of a highway through Northern Ontario; (2) Construction of a Trans-Canada Highway; (3) The request for co-operation between the two Governments in the construction of said highways.

He also laid before the House,—Report by Custodian of receipts and expenditures in respect to Reparations Payments, as required by section 8 of chapter 55 of 1929 Statutes.

And also,—Interim Report of Errol Malcolm McDougall, K.C., of Montreal, a Commissioner appointed under Part I of the Inquiries Act, Chapter 99 of the Revised Statutes of Canada, 1927, to inquire into Illegal Warfare Claims, for the purpose of determining whether they fell within the first Annex to Section 1 of Part VIII of the Treaty of Peace with Germany, and the fair amount of such claims, dated at Ottawa, March 6, 1931.

On motion of Mr. Cahan it was ordered,—That 500 copies in the English language and 200 copies in the French language of the Interim Report to His Excellency the Administrator of the Government in Council, dated March 6th, 1931, made by Errol M. McDougall, Esquire, a Commissioner appointed to investigate and report upon illegal warfare claims and reparations payable in respect thereof, laid on the Table of the House this day, be printed forthwith, and that Standing Order 64 in relation thereto be suspended.
