Mr. Sharp, seconded by Mr. Lang, moved,—That, each Standing Committee to which the Main Estimates, 1974-75 or Supplementary Estimates (A), 1974-75, are referred, shall report, or shall be deemed to have reported, the said Estimates to the House not later than October 22, 1974;
