Wheat Market Sags Lower Holders Become Discouraged

Decline Follows Weak Opening—Good Crop Advice Continue to Contribute to Weakness

CHICAGO, Aug. 14.—The grain markets sagged to-day and closed near the bottom. Sept. wheat, 10c to 10 1/2c, corn, 10c to 10 1/2c, and Sept. oats, 10c to 10 1/2c, under Saturday's selling coming mostly from tired holders. Provisions were steady. Cash wheat was relatively firm, but sympathy with wheat and corn generally, although there was not wanting a pessimistic note in the fact that the amount of good weather, such as was reported to-day, could rescue the crop from the damage suffered in July. The more influential long, however, preferred to give the crop a chance and prices declined under their influence. Cash corn dropped from 10c to 10 1/2c. September sold between 10c and 10 1/2c. The oats market was unimportant. The cash article declined 1/2c to 10c in the staple market and futures to 10c. September prices ranged between 10c and 10 1/2c, the close being at the bottom. Provisions were steady, despite a heavier run of hogs than had been expected. September pork and lard were unchanged at \$11.75 and \$11.75 respectively, and September lard 1/2c down, at \$11.75.
