#### NATIONAL CAPITAL

##### DISCUSSIONS TO CHANGE CAPITAL'S IMAGE

**Mr. André Fortin (Lotbinière):** Mr. Speaker, I have a question for the Prime Minister.

Following publication of a document requested by the Royal Commission on Bilingualism and Biculturalism, pointing out that the Ottawa municipal administration has considered language and culture issues from an essentially provincial standpoint, would the Prime Minister tell the house whether or not he intends to have talks with municipal officers in order to change the federal capital's tarnished image?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, we have already entered into discussions with Quebec and Ontario provincial authorities and we reached an agreement to the effect that the whole capital area should truly mirror Canada's distinctive features, but needless to say we must proceed through provincial governments since municipalities come essentially under their jurisdiction.

**Mr. André Ouellet (Papineau):** Mr. Speaker, I have a question for the Secretary of State. Will he at last agree that a clean-up is required at all levels of the C.B.C., and tell

#### LABOUR CONDITIONS

##### CANADAIR LIMITED, MONTREAL—LAY-OFF OF EMPLOYEES

**Hon. James Richardson (Minister of Supply and Services):** Mr. Speaker, last Wednesday the hon. member for Nanaimo-Cowichan-The Islands asked me about notice given to employees being laid off by Canadair Limited, particularly because some of this company's work is under contract with the government.

The government is, of course, concerned about the fair treatment of all employees who work in plants with which the government has contracts. Our contract with Canadair requires that the company "shall comply with all labour conditions and with all health conditions and requirements applicable to the work". However, specific and detailed matters such as length of notice, or pay in lieu of notice, are matters of negotiation and agreement between the company and the local unit of the union and do not form part of the government's contract with the company.

I have been advised by Canadair Limited that all employees who were laid off received
