I proceeded to the Norway House Indian Agency to escort Indian Agent P.G.Lazenby on the annual treaty trip in his agency. Leaving the Agency at 12.30 P.M. we proceeded to the Island Lake Reserve arriving there at 2.00 P.M. Transportation was provided by Wings Ltd. a Fairchild, type 71, CF-AWX, piloted by R.A.KITELLY.

Payments were completed at Island
Lake on this date, and the party proceeded to Gods Lake
Reserve. On this and all subsequent flights, transportation
was by a Fairchild, type 82, CF-AXF, owned by Wings Ltd,

on this date the Treaty Party proceeded to Oxford House, where it remained until 4-8-39, when it returned to Norway House.

7-8-39

- On this date accompanied by S/Cst JMcDonald and prisoner K Robinson, travelling by Canoe
  and O/Board Motor, Code # 7356, I proceeded with the
  Treaty Pmby to the Cross Lake Indian Reserve, where I
  remained until 10-8-39 when I returned to Norway House.
- patrol appeared to be in good health. No complaints of a Criminal nature were received. At Island Lake a check of all persons operating Radio Sets was made, and a licens sold in every case. Ost Forbes of the God's Lake Det, was contacted at Oxford House, where he was investigating a B.E & T. At Cross Lake ten cases under the Liquor Sections of the Indian Act were tried before the Agent, and a conviction registered in each case.
