How to proceed in actions above 40f.

actions that exceed in value the sum of forty shillings, Quebec currency, shall be commenced and proceeded in at the same times and in the same manner as is directed for the trial of causes above ten pounds sterling.

## CHAP. V.

An ACT to guard against accidents by Fire in this Province.

Preamble.

7 HEREAS the inhabitants of the province of Upper-Canada, are liable to receive great injuries from accidental fires that may happen therein, Be it therefore enacted by the kings most excellent majesty, by and with the advice and consent of the legislative council and affembly of the province of Upper Canada, constituted and affembled by virtue of and under the authority of an act passed in the parliament of Great-Britain, entitled an act to repeal certain parts of an act passed in the sourteenth year of his majesty's reign, entitled "An act for making more effectual provision for the government of the province of Quebec in North America, and to make further provision for the government of the faid province," and by the authority of the same, that from and after the first day of November in the year of our Lord one thousand seven hundred and ninety-two, it shall and may be lawful for the magistrates of each and every district in this province, in quarter fessions assembled, to make such orders and regulations for the prevention of accidental fires within the same as to them shall seem meet and necessary, and to appoint fire-men or other officers for the prevention of accidental fires, or for the purpose of extinguishing the same when such may happen, and to make such orders and regulations, as to them may feem fit or necessary, in any town or towns or other place or places in each district within this province, where there may be forty store-houses and dwelling houses within the space of half a mile square.

Magifrates in direct fessions authorized to make regulations to prevent accidental fires, where 40 store and dwelling-houses are enacted within half a mile square.

## C H A P. VI.

An ACT for the more easy and speedy Recovery of small Debts.

Preamble.

THEREAS it will contribute to the conveniency of the inhabitants of this province to have an eafy and speedy method of recovering small debts, Be it therefore enacted by the kings most excellent majesty, by and with the advice and consent of the legislative council and affembly of the province of Upper-Canada, constituted and affembled by virtue of and under the authority of an act passed in the parliament of Great-Britain, entitled an act to repeal certain parts of an act passed in the fourteenth year of his majesty's reign, entitled, " An act for making more effectual provision for the government of the province of Quebec in North America, and to make further provision for the government of the said province;" and by the authority of the same, that from and after the passing of this act, it shall and may be lawful, for any two or more justices of the peace, acting under and by virtue of his majesty's commission within the respective limits of their said commmissions, to assemble, sit and hold a court of justice, to be called a court of requests, on the first Saturday and third Saturday in every month, at some fixed place within their respective divisions, which division shall be ascertained and limited by the justices affembled in their general quarter sessions or the greater part of them, and the place for holding the faid court, shall be fixed by the justices acting in and for the faid division or the greater part of them; and the faid justices are hereby declared, constituted and appointed to be commissioners to hear and determine all such matters of debt as are herein after mentioned, and shall have power and authority by virtue of this act to give judgment and decree, and award execution thereupon, with fuch costs as shall be herein after specifi-

Two or more justices may hold a court of quests on the 1 & 3d Saturary of every month,

within their respective divisions to be ascertained in qr. sessions.

And give judgment, & award execution thereupon as shall feem just.
