Last Regular Meeting of the City Council

For Eventful Century Now Closing -Fair Financial Record.

Expenses All Met-Parting Shot at the Engineer—That Official Ably Defended—Concessions to Tobacco Factory—Complimentary Resolution

The municipal council of 1900 has held its last regular meeting, and more than usual thoughtfulness pervaded the session. The worthy city fathers were apparently impressed with the fact that they were component parts of the dying council for the final year of a great century. It must be acknowledged, however, that they forgot all romantic associations in one or two instances, and were very much occupied with the burning present. They had the satisfaction of learning that the expenses of the year have been met, and that no legacy of deficits will be left to burden the new council. By the exercise of prudence and economy, the council has lived within its income. The sporadic outburst of individual dissatisfaction with the city engineer, that crops out, once in a while, was once more in evidence. It was shown, however, that while certain aldermen will occasionally say harsh things about this department, when it comes right down to hard-pan, they will not express themselves disfavorably to the engineer. An opportunity to express an opinion of downright disapproval of the engineer was given by Ald. Winder's motion to discharge him, and the absolute silence that greeted his, if I can find a seconder," was in itself a volume of argument on the engineer's behalf.

Engineer Graydon submitted statement showing that the expendi-ture on the public works, under his charge, had amounted to \$16,845. The estimate was \$18,000, thus leaving a gratifying surplus.

Mid. Cooper wanted to know where he got the surplus. "What," he asked, had become of the \$4,000 of sewer money? Where is it gone to?"
Ald. Winnett — We didn't touch a cent of it.

'Well, we haven't had a cent money spent on the streets of No. 4 ward," said Ald. Cooper. "The money was left for work in No. 4 ward, and it's been spent in the others." Ald. Gerry called Ald. Cooper's attention to the fact that in No. 6 ward money had been spent on sewers

There have been no pay sheets stuffed this year," said Ald. Winnett, "and no crooked work has been done."
