The socialistic faction based their arguments on the anthracite strike and the combination of coal companies and railroads, and that a tendency not to treat with miners, "according to the laws of man and God," made it necessary for the Government to take some

such action. Delegate Walker, of Illinois, said that the coal companies and railroads were now in a combination injurious to the interests of the people, and were holding back coal to boost prices. Delegate Lusk, of West Virginia, also charged that the heartless attitude of the coal operators and railroads not only affected the miners but the people as well. The controversy was referred back

to the committee.

\$3,000 FOR DRINK AND NIGHT'S SLEEP

Mitchell's Statement Re Idle Barney Thought the Coupons Were Cigarette Tickets.

Altogether \$5,500 Worth of Bond Coupons Recovered by New York Detectives.

New York, Jan. 23 .- A little bundle of coupons from railroad bonds, value \$ at \$3,000, and negotiable as treasury notes, but traded for a night's lodging and a few drinks of Tenth avenue whisky by a homeless man led to the recovery by central office detectives the miners are not obeying President of \$5,500 worth of coupons that were Mitchell's request to make extra efforts part of a \$7,800 mail robbery perpetrated more than two years ago. Part of the amount recovered was found in the basement of the general postoffice among the debris of a partition which had been removed from the registry division office. Edmund J. Bell was a clerk in this office at the time of the robbery. Although only 19 years old and working for a small salary, he played the part of a "manabout-town." He was arrested Nov. 30, 1900, charged with stealing \$2,000 from a registered letter, for which he was convicted. He was also charged with the \$7,800 robbery, but no case was proved against him.

STOLEN TWO YEARS AGO. The officials of the Corn Exchange Bank notified the Pinkerton Detective Agency Jan. 16 that \$3,000 worth of Southern Pacific, Northern Pacific, Canadian Pacific and Chicago and Northwestern bonds had been presented for collection at its branch bank at Forty-second street and Eighth avenue. The coupons were for interest due October, 1900, and the tardiness in presentation aroused the suspicions of the officials. The Pinkerton agency notified Capt. Langan, of the central office, who detailed Detectives Cafferty and Samuel Price on the case.

They learned that the coupons had been presented at Ralph Knickman, a saloonkeeper at Tenth avenue and Forty-third street. Knickman said his bartender, Frank Pontius, of No. 501 West Forty-fourth street, had given to him the coupons. Pontius told the detectives that a man whom he knew as "Barney" had accepted a night's lodging and some whisky for the BARNEY FOUND.

After a long search a man who said he was Barney Manning was found digging a cellar at Tenth avenue and Fiftieth street.

'Dem was cigarette tickets," Barney explained when asked about the coupons, and he chuckled as he told the tectives how he had secured a warm bed and hot whisky for the bundle. told where he found them while working for a carpenter in the posto Barney was taken to the postoffice and showed the detectives where he had placed a dismantled partition in the basement. They "screened" the pile of lath and mortar and found a bundle of coupons worth \$2,500. The registered package, containing

\$7.800 in coupons was mailed Sept. 16, 1900, by Hope & Sons, bankers of Am-1900, by Hope & Sons, bankers of Amsterdam, Holland, to Heidelbach, Ickelheimer & Co., for collection, was reported as missing and had never been recovered. The package had been insured by S. Chubb & Son. No. 8 William street. The coupons were in-spected by the firm yesterday and tallied with the inventory of the missing package.

It is even too good to use for watering the streets, and there is river water available for that purpose. But the springs at Springbank are not taken up yet, for below the Colville pond is much that is running to waste which should be collected: in fact, a second pond should be made There is much water to be had at the other, or north, side of the river if it could be turned to the city's use, all the way from the high clay bank at Byron bridge to the waterworks dam. Below Byron bridge is a further supply should Springbank be extended further west. We are a growing city, and are extending west,

The water from Redmond's pond, if available for the city's use, would have to be filtered, but this could be done on the north side of the river and conveniently and cheaply, and would reach the pumphouse without pump-






