

Act to amend the Post Office Act and has agreed to report it with the following amendments:

*Clause 4*

Strike out line 2 on page 5 and substitute the following therefor:

“of Commons; or

(c) the Parliamentary Librarian or the Associate Parliamentary Librarian.”

*Clause 6*

Delete Clause 6 on page 6, and substitute the following therefor:

“6. Section 19 of the said Act is repealed and the following substituted therefor:

19. *Letters, books, tapes, records and other similar materials* for the use of the blind may be sent free of postage in accordance with the regulations and the Governor in Council may make further regulations providing for compensation to be paid to the Canada Post Office for the transmission by post of such letters, books, tapes, records and materials.”

Your Committee has ordered a reprint of Bill C-240, as amended for the use of the House of Commons, at the report stage pursuant to Standing Order 75(2).

A copy of the relevant Minutes of Proceedings and Evidence (*Issue No. 18*) is tabled.

Mr. Davis, a Member of the Queen's Privy Council, laid upon the Table,—Copy of Communiqué issued following Canada-United States Ministerial Meeting on Great Lakes Pollution, held at Washington, D.C., June 10, 1971.—Sessional Paper No. 283-6/32A.

Bill C-229, An Act respecting unemployment insurance in Canada, as reported (with amendments) from the Standing Committee on Labour, Manpower and Immigration, was again considered at the report stage.

Mr. Mackasey, seconded by Mr. Greene, moved,—That Bill C-229, An Act respecting unemployment insurance in Canada, be amended by striking out lines 30 to 32, inclusive, at page 19 and substituting therefor the following:

“section 46,

(c) payment was retained under subsection (3) of section 49, or

(d) he was fully employed during such period.”

After debate thereon, the question being put on the said motion, it was agreed to.

Mr. Knowles (Winnipeg North Centre) for Mr. Skoberg, seconded by Mr. Harding, moved,—That Bill C-229, An Act respecting unemployment insurance in Canada, be amended by deleting paragraph (a) of subclause (2) of clause 44, in lines 21 to 24 at page 27, and by substituting therefor the following:

“(a) he is not directly involved or participating in the labour dispute that caused the stoppage of work; and”

After debate thereon, the question being put on the said motion, pursuant to section 11 of Standing Order 75, a recorded division was deferred.

Agreed,—That recorded divisions on the said bill pursuant to section 11 of Standing Order 75 be deferred until 8.00 o'clock p.m., Monday, June 14, 1971.

By unanimous consent, Mr. Mackasey, seconded by Mr. Macdonald (Rosedale), moved,—That Bill C-229 (Reprinted as amended and reported by the Standing Committee on Labour, Manpower and Immigration) be amended by striking out lines 41 to 44 inclusive on page 34 and lines 1 to 3 inclusive on page 35 and substituting therefor the following:

‘and delineating the boundaries thereof and determining residence within such regions;

(u) averaging any rates of unemployment for the purposes of paying extended benefits and prescribing the manner in which such averaging shall be carried out;’

After debate thereon, the question being put on the said motion, it was agreed to.

Mr. Alexander, seconded by Mr. McKinley, moved,—That Bill C-229, An Act respecting unemployment insurance in Canada, be amended by deleting subclauses (1), (2) and (3) of clause 64 at pages 41 and 42 and substituting the following:

“(1) The employer's premium to be paid in a year by an employer of an insured person shall not exceed 1.4 times the employee's premium for that year.”

and by deleting the words “but subject to paragraph (a) of section 65” where they severally appear at the end of subclauses (4) and (5) of the said clause at page 42 and by renumbering these subclauses as (2) and (3) respectively.

Mr. Alexander, seconded by Mr. McKinley, moved,—That Bill C-229, An Act respecting unemployment insurance in Canada, be amended by deleting clause 65 at pages 42 and 43.

After debate thereon, the question being put on the said motion, pursuant to section 11 of Standing Order 75, a recorded division was deferred.
