*POSTAL SERVICE-MAIL DELIVERY, ROUYN AND NORANDA

Mr. CAOUETTE:

What steps have been taken to establish a letter carrier delivery in the twin cities of Rouyn and Noranda?

Mr. BERTRAND (Laurier): I should like to give a verbal answer to this question. The twin cities of Rouyn and Noranda, if treated as one postal area, or in other words served by one post office, would have a sufficient number of calls to warrant a letter carrier delivery service, and in the event of that service being established the patrons would enjoy a drop letter rate of postage throughout the whole community served by the one office. Neither the Rouyn public building nor the building housing the Noranda post office is large enough to accommodate the necessary letter carrier staff. The question of providing a new building to take care of the needs of the combined area is under consideration, but progress is difficult due to the uncertainty as to whether the suggested arrangement would be acceptable to both communities. In the meantime we can do nothing further.
