MIDDLE EAST-REQUEST FOR STATEMENT ON LATEST DEVELOPMENTS

> Right Hon. J. G. Diefenbaker (Prime Minister): Mr. Speaker, I think the proper way to answer that question might be to outline in general what has taken place and then in my concluding words make particular reference to the question asked by the Leader of the Opposition.

> Hon. members already will be aware of the further grave turn of events in the Middle East which has led to the dispatch of United Kingdom airborne forces to that area "to protect the government of Jordan from a military coup", to quote the words used today by the Prime Minister of the United Kingdom in the British House of Commons. I was notified in the early hours of this morning of the United Kingdom government's decision to take this step and will, of course, remain in constant and continuing touch with that government in regard to events as they occur.

> The Prime Minister of the United Kingdom told the House of Commons that the decision to air-lift forces to Jordan had been made in response to an urgent appeal which King Hussein had addressed to both the United States and the United Kingdom for military assistance to forestall a plot to overthrow by force the legitimate government of Jordan. The conspiracy against the king, he said, was external in origin and threatened the independence and territorial integrity of Jordan. The United Kingdom government, fully conscious of the gravity of the decision they were taking, concluded that if law and order were not to collapse entirely throughout the Middle East the appeal of Jordan's king had to be met and the position held until the United Nations could devise some alternative system of security for that area. I am sure that members of the house will fully appreciate that in the circumstances the United Kingdom government had no alternative but to act as it has done, and in that connection it had the full support of the United States government.
