# Government Organization On clause 47—Other services

Mr. Crouse: In respect of clause 47, I wonder whether the minister could give us a little better explanation of what this clause means. It states that nothing in this part precludes the minister from providing, with the prior approval of the Governor in Council, any services that are within the ambit of the duties, powers and functions of the minister under this part. Could the minister amplify the responsibility this clause defines?

Mr. Jamieson: Mr. Chairman, this clause enables the minister, subject to a request from a customer department or agency and approval of the Governor in Council, to provide any services dealt with in the act on behalf of Crown corporations and other government organizations. The services in respect of purchasing and supply at the federal level can be further increased, if these services are requested, to provincial or municipal governments in Canada so long as the cost would be recoverable from the agency concerned. If it should become evident that in respect of some bulk purchase we could be of assistance to a provincial government or some other agency we are not prohibited from doing that, provided the cost is recovered.

In so far as Crown corporations are concerned, the act stipulates that there are certain classes of Crown corporations which are automatically included in the procurement responsibilities of the department. Some are outside such as, for example, the C.N.R. and the C.B.C. This, however, is an enabling clause in the sense that if these agencies wish to take advantage of our purchasing capability they have the ability to do so and we have the ability to respond.

The Deputy Chairman: Shall clause 47 carry?

Mr. Fortin: I would like to ask a very short question, Mr. Chairman.

Could the Minister of Supply and Services tell us if the appointment of auditors for the various Crown corporations will come under his jurisdiction now that his department and the office of the Treasury Board have merged?
