## QUEBEC PARTICIPATION IN STUDENT LOANS PROGRAM

### Question No. 1,562-Mr. Maite:

Does the Province of Quebec receive from the federal government any compensation in connection with the Canada Students' Loan Program and, if so, by what means?

Hon. E. J. Benson (Minister of Finance): Section 12 of the Canada Student Loans Act provides for an alternative payment to a non-participating province which operates its own student loans plan. This payment is related to actual statutory expenditures incurred during a loan year by the federal government (e.g. interest payments and loss claims) and is calculated on the basis of the 18-24 year population in a non-participating province repulsive to that in the participating provinces. Quebec qualifies for payments under this provision, and the following such payments have been made to date; 1965, \$74,262.05; 1966,

\$757,447.99; 1967, \$1,230,572.14; 1968, \$2,402,-552.55.
