ALLEGED HARASSMENT OF TRANSIENTS BY POLICE AND OTHER AUTHORITIES

Mr. P. B. Rynard (Simcoe North): I would like to address my question to the Minister of National Health and Welfare. The minister, in his program on drugs, approaches the problem by treatment and research. However, a national health and welfare study on transients indicates that 38 per cent of last summer's travellers were subject to harassment by police and other authorities. When will the Minister of National Health and Welfare and the Minister of Justice meet to solve this inconsistency?

Hon. John C. Munro (Minister of National Health and Welfare): I do not agree with the observations of the hon. member. If he is asking a question concerning legal sanctions in this area, I think he should direct it to my colleague, the Minister of Justice.

Mr. Rynard: I will readdress my question to the Minister of Justice.

Hon. John N. Turner (Minister of Justice): Would the hon. member be good enough to specify which part of the question he would like me to answer?

Mr. Rynard: Yes, I will, Mr. Speaker. A national health and welfare study has indicated that 38 per cent of last summer's travellers were subject to harassment by police and other authorities. When will the Minister of National Health and Welfare and the Minister of Justice meet to solve this inconsistency?

Mr. Speaker: Order, please. Perhaps the Chair might have suggested to the hon. member from the start that this appears to be an argumentative question. I would think the hon. member is really making a submission to the ministers concerned.

Mr. Rynard: I should like to address a supplementary question to the Prime Minister. Will he give consideration to granting a day of debate to discuss this troublesome situation?

INVESTIGATION OF TASK FORCE FINDING CONCERNING POLICE METHODS

Mr. Les Benjamin (Regina-Lake Centre): Mr. Speaker, I have a supplementary question for the Minister of National Health and Welfare. It concerns the report of the task force on youth services. Since the report says that in many cases police agencies used highly questionable methods to gain information leading to arrests and convictions, can the minister advise whether or not he is having this matter investigated further and whether he has asked the Solicitor General to investigate it and take it up with the Attorneys General of the provinces?

Hon. John C. Munro (Minister of National Health and Welfare): No decision has been taken yet with respect to

Mr. Benjamin: May I ask the Minister of Justice whether, in view of what this report has to say about the present vagrancy laws and a uniform juvenile age, he is giving consideration to bringing in amendments to these laws?

ADVERTISING OF JOB OPPORTUNITIES IN EUROPEAN PRESS

Mr. Barry Mather (Surrey): My question is addressed to the Minister of Manpower and Immigration, Could he say whether his office has received representations from groups such as the Federation of Parents and Teachers of British Columbia urging the abandonment of job advertising published in the European press reportedly stating that there are job opportunities in Canada at this time of unemployment?

Hon. Otto E. Lang (Minister of Manpower and Immigration): Mr. Speaker, I am not sure whether that group is among the groups which did write about the subject some time ago. The fact is that specific job advertising was stopped by the department some months ago, although of course the department continues to bring Canada generally to the attention of people abroad as part of the ongoing campaign for the future.
