

*Oral Questions***AIR TRANSPORT****ALLOCATION OF ROUTE TO MILAN, ITALY—INQUIRY AS TO DECISION**

**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, my question is to the Minister of Transport. A couple of weeks ago I asked him in the House whether a decision had been reached whereby Air Canada would be granted the route to Milan. Can the minister tell us what the present position is?

**Hon. Jean Marchand (Minister of Transport):** Exactly the same position as two years ago—

**Mr. Marchand (Langelier):**—two weeks ago.

**An hon. Member:** You were right the first time!

**Mr. Diefenbaker:** I realize the minister is in a position where he proves the meaning of inertia on all occasions, but this is the first public admission. Why is the decision being withheld? Why is it not being taken? Is it a fact that as a result of the discomfiture of Air Canada employees, who believe the government is discriminating against them, Mr. Pratte, the Chairman of Air Canada, has threatened to resign unless granted this particular route?

**Mr. Marchand (Langelier):** No, Mr. Speaker, I am not aware of any threat of resignation on the part of Mr. Pratte. I think Mr. Pratte is interested in having the best airline it is possible to get in the circumstances.

**Mr. Diefenbaker:** Isn't the minister, too?

**Mr. Marchand (Langelier):** I share his objectives in that field. We think we have good reason not to designate Milan at this moment because we want to have a broad policy and it will be included in the policy which is to be made known, I hope, in a few weeks.
