As stipulated by Section 72 of the Bank Act, chartered bank cash reserves may be maintained in the form of notes of, and deposits in Canadian currency with the Bank of Canada. Information is not published for each bank on the amounts of these two components separately; the combined total is shown below for the latest month available.
