CHINESE WERE FABRICATED TO RUIN ENGLISH OFFICIAL

Amazing Story of Conspiracy Which Was Disclosed at Trial in Calcutta Court.

An astounding conspiracy to ruin an English public official by means of false criminal charges and the fabricated evidence of scores of native witnesses has just terminated at the Calcutta criminal sessions in the triumphant vindication of the accused man.

Algeron Caswell Roll, an Englishman widely known in Bengal, had been since 1888 manager, roughly, to the eastern railway company, an estate in the jurisdiction of the Calcutta court, for which he was an auditor.

Embargo on Cattle. Canada to Make Another Attempt to Remove It. London Morning Post: It is said on good authority that the Dominion government will shortly make another attempt to secure the removal of the embargo on Canadian cattle imported into the United Kingdom.
