## RULE

The following

"It shall also be the duty of the Society to provide for the support of Orphans of deceased members who have been admitted to this Society thereof.

1st. In accordance with the objects of the fund shall be the receipt of other contributions from all members of all premium money from; and this and no other.

2nd. A statement shall be made to whom, together with the management of the fund shall be paid a

3rd. The rules of the Society and Orphans' shall be as follows.

4th. Every member wishing to avail himself of the benefits of the Society from the 10th day of his admission shall be liable to the provisions of the regulations, and shall be bound to observe the same.

5th. Any member who shall receive such contributions as are provided for in these terms as they shall be.

6th. The contributions shall be payable by every member on the date of his first admission, and shall be applied toward payment of the same.
