

There are as many as 100 million marks available for redemption for the twenty million marks in gold and silver coins minted in 1926. On the other hand, the government estimates that the next instalment of 100 million marks, due on May 1, 1921, will be paid in the form of the surrender of property, but it appears that it is still in mind for the government to issue in annual instalments.
