DEBATES:—Select Committee appointed to supervise the Official Report of the Debates, 20. **FIRST REPORT**, recommending that no contractor for the Debates, or any of his employés shall be permitted to be on the Staff of the House, 71. Motion for concurrence; Amendment moved, that the Report be referred back for further consideration; Agreed to; Report referred back accordingly, 116. **SECOND REPORT**, asking leave to withdraw their First Report, and to substitute therefor a recommendation to the effect that the contract system for the translating of the Debates be done away with; and that four Translators be appointed permanently and be under control of the Committee; also recommending that Mr. J. O. Marceau be appointed as an additional French Reporter, for remainder of Session, 176. Concurred in, 188. **THIRD REPORT**, recommending an additional allowance to Mr. Mortimer, contractor for Binding for previous Session; That three additional bound volumes be allowed to each Member; That tenders be called for binding for next Session; and that in future, no bound volume of Debates shall exceed 1200 pages; Concurred in, 205. **FOURTH REPORT**, recommending names of Translators to be appointed under conditions of Second Report;
