Mr. ILSLEY: The hon. gentleman has written me about this notice and has kindly consented to allow me some discretion as to the items which will be broken down. I am quite content to have it passed on the under-standing that information which it has never been considered in accord with the public interest to disclose shall not be disclosed. That applies to some of the items.

Mr. CHURCH: I have no idea of interfering with anything. This motion was called three times when I was away. Perhaps I

might say a few words about it. My idea in bringing this up last November was in regard to past loans. I thought the chartered banks, the Bank of Canada, the post offices and other departments could effect a great economy. I think the government might well pass it, and break it down after, if that is satisfactory. If not, it can be dropped, and I will bring it up again after the present loan is over.

Mr. HANSON (York-Sunbury): I assume that the hon. member for Broadview (Mr. Church) did not hear the statement of the Minister of Finance. Could not a return be brought down subject to the reservation stated by the minister? I have an idea that the hon. member thinks the introduction of this question at the moment, and the bringing down of a return based thereon, might be detrimental to the present loan, and of course he would like to avoid that. However, I should like to see some of this information brought down, though certainly I would not want it done at the expense of the present loan, if the minister thinks it might have that effect. But could it not be passed, with the understanding that the minister will use his own discretion as to what he shall bring

Mr. ILSLEY: It seemed to be the feeling of some of my colleagues at least that it would be undesirable to pass this motion now, and the hon, gentleman offered to let it drop. If he wants to put it on the order paper again, however, I can give him some of this infor-mation. Some of it I cannot give; some it would be most undesirable to give. For instance, there were some seventeen thousand canvassers in the last loan, and it would be an impossible task, and undesirable, to say what each one of them received.

Mr. HANSON (York-Sunbury): I agree.

Mr. ILSLEY: I think it would be desirable to let the motion drop now. In the meantime I will confer with the hon, member, and perhaps he and I can frame a motion that will bring down the information he desires.
