THE WHEELS.
LOWERED A RECORD.
SPRINGFIELD, Mass., Oct. 6.—Harry C. Tyler, of the Springfield bicycle club, lowered the world's record for a mile, standing start, at Hampden Park yesterday afternoon, making it in 2:01.5, which is 3.45 seconds faster than Windle's record made on same track Oct. 8, 1892. The quarters were 32, 1:03, 1:30.3-5, 2:01.3-5. This also breaks the three-quarter mile record. Duffie and Clarke reduced the quarter mile record, flying from 2:03.3-5 to 2:01.1-5.

LONDON, Oct. 6.—The Kempton Park autumn race meeting opened today. The main event of the day was the race for the Kempton Park great breeders' produce stakes of 5,000 sovereigns. It was won by Lord Alington's bay colt, Matchless. Lord Durham's bay colt Son O'Mine, was second and Mr. A. Cannon's bay filly Silver Image third.

CRICKET.
THE PHILLIPS LIKELY TO LOSE.

PHILADELPHIA, Oct. 6.—In the second great international cricket match between All Philadelphia and Australia the Philadelphia eleven were retired in their first inning for only 119 runs, and when darkness and rain combined to stop the game the Australians had compiled 76 for a loss of two wickets.

A cricket match has been arranged between the Australians and fourteenth century team at Detroit on Oct. 18 and 19. A 16-year-old boy named J. Moran is wanted in Chatham on the charge of stealing \$150. He is supposed to be in Windsor. The judgment of Judge Rose in the dispute between the city of Windsor and the county of Essex has been received. Mayor Fleming claims it favors the city. Mr. Clarke does not claim that the county has been upheld, but says that the whole thing is a jumble.

GIVING WOMAN A VOTE!

New York Democrats Want the Law So Amended.

SARATOGA, N. Y., Oct. 6.—The Democratic State convention met for the second day's proceedings at 11 o'clock. The platform contemplated President Cleveland on the suspicious beginning of the Administration, and pledges to him the support of New York Democrats in the passage of democratic measures; approves his action on calling the special session of Congress, and demands the speedy and unconditional repeal of the Sherman Act. "The transfer of legislative and executive branches of the Federal Government to the Democratic party was none too soon to correct, even if too late to avoid, the wide spread distrust caused by unscrupulous and plutocratic Republican legislation." The platform also favors liberal provisions for disabled Union soldiers.

One clause recommends that the constitutional convention to be held next year shall provide for an extension of the franchise to women.

Mrs. Lillie Devereux Blake, Caroline Gilkey Rogers, Miss Harriette A. Keyser and Mrs. James Brooks Greenleaf appeared before the committee appointed to nominate delegates to the constitutional convention to ask that a woman be appointed to represent the women.

Record-Breaking Trip of the Cunard Steamer Lucania.

The Brazilian Legation in London Disbelieves the News from Rio.

Wool Sales in London.

LONDON, Oct. 6.—At the wool sales today 5,000 bales were offered. Following are the sales and prices obtained: New South Wales, 700 bales, greasy, 54d to 58d; Queensland, 1,000 bales, greasy, 54d to 58d; Victoria, 1,000 bales, greasy, 54d to 58d; New Zealand, 2,000 bales, greasy, 54d to 58d; Cape of Good Hope and Natal, 200 bales, greasy, 54d to 74d.

Beats the Best Western Voyage.

NEW YORK, Oct. 6.—The fast Cunarder Lucania, which arrived to-night, has succeeded on this, her second westward trip, in establishing a new record, having made the passage in 6 days, 13 hours and 25 minutes. The record of the Paris was 5 days, 14 hours and 25 minutes. The Lucania therefore breaks the best record for a western voyage by 59 minutes.

The Rio News Doubtful.

LONDON, Oct. 6.—The representative of the United Press had an interview today with the secretary of the Brazilian Legation in this city, with reference to the situation in Brazil. The secretary declared that the majority of the reports purporting to describe the situation at Rio Janeiro were utterly unreliable and were often specially manufactured. The legation had received dispatches yesterday and today, and these dispatches made no reference whatever to a renewed bombardment of the city by the rebel admiral's fleet, to the capture of a steamer by the rebels or to the killing of civilians. If these alleged occurrences, or any of them, were true, the legation's dispatches would certainly have mentioned them.

Execution of an Anarchist.

BARCELONA, Oct. 6.—Pallas, the Anarchist, who on Sept. 24 made an attempt on the life of Gen. Campen, was shot to-day. During the 24 hours previous to his execution Pallas was confined in the military chapel, to which he had been escorted while singing an Anarchist song. The prisoner refused to kneel when sentence was pronounced, but he consented yesterday to sign a copy of his sentence, at the same time exclaiming that he was signing the death warrant of his judges, feeling certain that his brother Anarchists would avenge his death.

When the prisoner's back had been turned towards the firing party, the officer in command called the men to attention; their rifles, upon a second sharp order, were loaded, an officer read the sentence of the court-martial, the firing party sprang their rifles to the shoulder and took what appeared to be a horribly long and careful aim. To the right of the death platform stood its officer, his hand raised above his head. Then, like a streak of lightning, the glistering weapon descended, there was a flash of fire, clouds of white smoke, the rattle of rifles discharged in unison, and Pallas, the Anarchist, fell over on his back—dead. A few sharp military words of command and the body was carried away. The troops marched off, the crowds dispersed and all was over.

Matabels vs. British.

LONDON, Oct. 6.—A cipher dispatch from Mashonaland reached the Colonial Office today about fighting between the British and Matabels. The dispatch gives details of a skirmish between police of South African chartered companies and a band of Matabels. The police patrol was stationed on the Shashi River which flows along the southern portion of Matabeland and near the north border of British Bechuanaland. The Matabels advanced almost to the south bank of the river and fired on the police, who answered with a small volley. The Matabels then hastily retreated. Nobody on either side was hurt. The Matabels are supposed to have been a scouting party from Chief Lobengula's warriors, who are now believed to be on the march against Fort Victoria.

The appearance of Matabel warriors at Shashi River indicates that they intend to attack Tatit in the gold fields along the river, and spread over the country under Sir Henry Loch's jurisdiction. It is believed that the warriors have got beyond control of Chief Lobengula and are determined to force war at once upon the white settlers.

The imperial police will send at once to Tatit to prepare the town to resist the attack.

BEWARE OF THE WIRE!

Accident at Toronto That May Prove Fatal—A Woman Injured by a Fallen Electric Wire.

TORONTO, Oct. 6.—A serious accident which may yet terminate fatally occurred about 9 o'clock to-night through the cutting of an electric light wire. The wire, which was part of a house on King street west, and when the lineman cut it it fell to the street. Mrs. Halford, a woman of 35, was watching the fire, and in the dark ran against the wire. Her clothes were nearly burnt off her, both arms terribly burned to the elbows and her neck and breast slightly scorched. It was several seconds before she could be released from the deadly embrace of the wire, and when taken to Dr. Wood's office her injuries were found to be very serious.

She will lose the use of one arm and may possibly not get over the shock. Chief Ardagh, of the fire department, and two of the men, also received minor shocks.

WHIPPING WELL MERITED.

A Scoundrel Sentenced to Five Years Imprisonment and Ninety Lashes.

ST. THOMAS, Oct. 6.—Wm. Murray, the tramp soap peddler, who last Thursday criminally assaulted Louisa Locke, the 5-year-old daughter of A. T. Locke, Horton street, and attempted to assault Emmaline Evans, 12 years old, daughter of Mr. W. J. Evans, Crocker avenue, was arraigned for trial before Judge Hughes this morning. County Attorney Donahue, prosecuted, and R. H. McConnell, at the request of the judge, defended the accused.

After hearing a large number of witnesses Murray was found guilty on both charges and sentenced to five years in penitentiary, and to receive 90 lashes, 30 one month after incarceration, 30 more one year afterward, and 30 two years after incarceration. Murray broke down, wept and begged to be spared from the lash.

Late Canadian News.

A \$7,000 Yacht Burned—Large Increase in Montreal's Street Railway Earnings.

Hunter's planing mills on Dufferin street, Toronto, was damaged by fire Friday.

The capital of the Montreal Street Railway Company will shortly be increased from \$2,000,000 to \$5,000,000.

Hon. G. W. Ross, Minister of Education, was in Ottawa on Friday and addressed the Normal School students.

Fires have swept over the timber districts of Northern Manitoba, and have done an immense amount of damage.

Sir Chas. Tupper passed through St. John, N.B., to Amherst on Friday, accompanied by Lady Tupper and William Tupper.

The new steam yacht Rita, valued at \$7,000 and insured for \$5,000, was totally destroyed by fire on St. John River Thursday night.

St. John Episcopal congregation, Port Arthur, is on the lookout for another incumbent. Stipend, \$1,000, extras and a good parsonage.

This year's earnings of the Montreal street railway exceed those of the previous year by \$186,357.38. The fares carried were 15,290,055.

Hon. N. Clarke Wallace, Controller of Customs, and Hon. J. F. Wood, Controller of Inland Revenue, held a tariff conference at Markham on Friday.

The project to build a new bridge at Niagara for the accommodation of the Grand Trunk, Erie and Lehigh Valley Railroads is being still discussed.

The total clearings of Canadian banks this week were \$30,591,944, compared with \$17,739,455 last week, and \$24,892,421 for the corresponding week of 1892.

American capitalists are at present prospecting some of the gold lands in the Beauce district in the Province of Quebec, with a view of developing mines.

The first annual convention of the Electro-unionist Association of Canada was held in Guild Hall, Toronto, on Friday, when E. J. Browne, Toronto, was elected president.

Mrs. M. J. Daly, the American lady from Waterbury, Conn., who was incarcerated in Longue Point Asylum at the instance of her husband, is to be released by order of Judge Davidson.

Acting under instructions from Government Detective Silas H. Carpenter, the guard which has been keeping watch over Hooper, suspected of wife murder, has been withdrawn.

An Ottawa paper publishes a report that a political deal is on hand to make C. H. Mackintosh, Lieutenant Governor of Manitoba, and Mr. A. W. Ross, Lieutenant Governor of the Northwest.

There was a Conservative demonstration at Dunville on Friday. The Premier and his colleagues were met at the station by the town council and a number of local citizens and the usual programme was carried.

At Hamilton on Friday Samuel Levy was tried on a charge of obtaining \$22 from Abram A. Rosenthal, a Toronto pawnbroker, by false pretense. Levy was found guilty and sentenced to two months with hard labor.

W. H. Brown, car inspector on the G. T. R. at Brockville for many years, was on Thursday preceded by his friends with a purse of money on the occasion of his removal to Canada to fill a similar position for the same company.

The annual conference of the Ontario district of the United Brethren in Christ is in session at Attercliffe, presided over by the aged and venerable Bishop Weaver of Diocese, Ohio, who has been preaching for over 50 years. There is a large attendance.

The Dominion Prohibition Commission met in Hamilton Friday morning. Judge MacDonald presided. The other members present were Rev. Dr. McLeod and E. F. Clarke. Mayor Blaisie and Police Magistrate Jellis opposed prohibition. The commission will come from Hamilton to London.

Mr. Somers, employed at Jess J. Living's box mill, B. Beaulieu, narrowly escaped instant death on Friday. He was putting on a belt down stairs when the belt caught his clothing and he made four or five rounds with the belt, passing through the ceiling in the floor. He is badly hurt, but may recover.

HOOPER'S CASE.

The Suspected Man to be Taken to Quebec for Trial—Sympathy Expressed by a S. of E. Lodge.

MONTREAL, Que., Oct. 6.—Detectives have ascertained that Hooper on Sept. 17, the day he left Montreal, was accompanied by R. W. Webb, a Montreal druggist, half an ounce of prussic acid which he stated was to poison a dog. The poison was given on an order from E. G. Cameron. An order was sent to Port Hope this evening to arrest Hooper who will be brought to Quebec for trial.

OTTAWA, Oct. 6.—At a meeting of Bowdoin Lodge, S. O. E., there was a verbal expression of sympathy with R. W. Hooper, a member now lying under the suspicion of having poisoned his wife. It was resolved that Bowdoin Lodge would support Derby Lodge, of which he was a member, in whatever measures the latter should take in procuring him a fair trial.

THE Michigan Liquor Dealers' Association recently met in delegate convention in Grand Rapids, and resolved to oppose the law giving women municipal suffrage, because, according to their circular, "giving to the women a franchise with an educational restriction strikes a blow at our interests and rights."

BISHOP JOHN H. VINCENT, of the Methodist Episcopal Church, has recently been appointed a member of the board of university preachers at Harvard. Bishop Vincent is best known through his work in Sunday schools and his connection with the Chautauqua movement, of which he was the originator. He is 61 years old, and has been a preacher ever since his 18 year.

STATISTICS are said to show that young men do not, on the average, attain full physical maturity until they arrive at the age of 28 years. Prof. Schellier, of Harvard, asserts, as the result of his observations, that young men do not attain to the full measure of their mental faculties before 25 years of age. A shrewd observer has said that "most men are boys until they are 30, and little boys until they are 25;" and this accords with the standard of manhood, which was fixed at 30 among the ancient Hebrews and other races.

MISS ELLA DARLING, a student at the State Normal School at West Chester, Pa., has got the authorities all stirred up. She is an advocate of the bifurcated skirt theory, and last Wednesday horrified the old maids of the staid Pennsylvania town by donning a pair of trousers and galloping through the streets astride a horse, a performance which she repeats daily. The spinsters want Miss Darling arrested, and Miss Darling wants them to try it. She is anxious to test the right of woman to wear trousers. The local constabulary, however, refuse to interfere, and there it rests.

FROGS, whether ill or not, become dark green or black if they are kept in a dark vessel in a sparingly-lighted room, but when a larger branch with green leaves is introduced into the vessel they all recover their bright green color, whether blind or not. In some way unknown the reflected green light acts either upon the nerves of the skin, or—what seems more probable, if Steinhel's experiments are taken into account—directly upon the pigment cells. Moreover, the sensations derived from the toes have also an influence upon the changes of color. When the bottom of the vessel is covered with a felt or with a thin wire net, the frogs also become black, recovering their green color when a green branch is introduced into the vessel.

Quick steps are indicative of energy or agitation. Tiptoe walking symbolizes surprise, curiosity, discretion or mystery. Turned in toes are often found in premature walk is represented as stooping, noiseless, with short, nervous, anxious steps. Slow steps, whether long or short, suggest a gentle or reflective state of mind, and measured steps, the toes are conspicuously turned out, the legs straightened. Where a vengeful purpose is hidden under a feigned smile the steps will be sinking and faltering, and every step will be a warning of the mind, invariably betraying uncertainty, hesitation and indecision. Ostentatious people, who in argument rely more on muscularity than on intellectual power, rest the feet flat and firm on the ground, walk heavily and slowly, and stand with the legs firmly planted and far apart.

WORKING TO WIN.

Echoes of the Plebiscite Convention.

Strong Feeling in Favor of Woman's Suffrage—Plea Pictures of the Talkers.

The suggestion of the Ontario branch of the Dominion Alliance that the convention should take hold of that organization and do with it what they thought wisest did not meet with much favor, and the Alliance officers very graciously decided not to push the matter further on the convention.

The question of the extension of the franchise came before the meeting in a resolution from Mr. John Cameron, of London, pointing to a removal of the disabilities that prevent women from voting today because of their sex. The sentiment of the resolution was very heartily endorsed by the meeting. The Ontario Government regretted of the women of the convention that the Legislature had decided upon a distinctive color being used for the women's ballot. It indicated a desire to obtain the electoral value of the Government rather than the true expression of the whole people.

The Education Department was commended for the attention it is giving to the study of temperance and physiology in the schools, and the new text book on the subjects just issued by Wm. Briggs was referred to as evidence of an advance on these lines.

It was worthy of remark that the plebiscite found some of its warmest defenders in the ranks of those who are politically opposed to the Government that granted the plebiscite. Joseph Gibson, of Ingersoll, a prominent Conservative, took occasion to argue ably for the right of the plebiscite. So with Ed Carwell and Hon. Senator Vidal, not to name any others.

Fears that differences of opinion among not a few leaders of the work as to methods of management might lead to a breach in the ranks were happily all banished. The various forces of the temperance army go united as one man into this plebiscite fight fired by the inspiration and enthusiasm that has come from the convention. The total number of delegates present at the convention was 1,114, easily the largest temperance convention ever held in the Dominion.

TEN PICTURES OF SOME TALKERS.

There was some rattling good speech-making in various intervals of the meetings when the convention was waiting, perhaps, for the report of a committee. A general favorite has been Joseph Gibson, of Ingersoll. He has the faculty of saying many common sense things and saying them with a degree of earnestness and enthusiasm that catches his audience. To many he is remembered as the erstwhile opponent of King and John Joseph Hawkins in the days of the Dunkin Act contest, and Joe downed these liquor champions every time.

A veteran orator whose voice is less frequently heard of late years on the Canadian platform is Mr. Edward Carwell, who has sometimes been termed the "Canadian Gough." Carwell spends the larger part of his time of late years in the United States, where he seems to have

become a general favorite. His fort in story-telling and mimicry, a line of temperance speech-making that has largely run its course in the work of the reform. Age is commencing to tell on this old favorite. He has for years held a prominent place in the councils of the Sons of Temperance. There was a constant call from the audience, when opportunity afforded the time, for Rev. J. H. Hector, the black knight. Hector was born in Windsor, Ont., though he has been a resident of the States for most of his lifetime. For a year and more he has been giving a considerable part of his time to campaign work in Canada. His large humor captivated his audiences from the start, but this he turns to good account in telling points against the liquor traffic. Hector has brought his wife and family to Canada and will spend the next three months talking for the plebiscite.

F. S. Spence, though in years yet a young man—his age is about 40—may be classed as one of the veterans of the temperance platform. It is safe to say that no other man in the past fifteen years at least, has made nearly as many speeches on this reform as the indefatigable secretary of the Dominion Alliance. He is beyond doubt the best posted man on the question of the same kind from different eastern cities till New York was reached and several more came from there.

On Oct. 3 White turned up at Chicago and began the same game there. Detective O'Neil got word that he obtained \$20 from the S. M. W. Jones Publishing Company by means of a worthless check and sent one of his men there to work with Pinkerton.

Yesterday morning Government Detective Rogers left Windsor with a warrant, and when he arrived in Chicago last night the arrest was made. If White refuses to return to Canada he will be prosecuted in the United States.
