

Mr. McIntosh, seconded by Mr. Neill, moved,—That the Third and Final Report of the Select Standing Committee on Industrial and International Relations, presented to the House on the 16th instant, be amended as follows:—

1. By striking out paragraph 8 thereof, and substituting the following therefor, viz:—

Your Committee further recommends that 750 copies in English and 250 copies in French of this Report, and the evidence upon which it is based, be printed in Blue Book form, and that Standing Order 64 be suspended in reference thereto.

2. And that the said Report, as so amended, be concurred in.

After Debate thereon, the said motion was allowed to stand.

Mr. Rinfret, a Member of the King's Privy Council, presented,—Return to an Order of the House of the 9th May, 1928, for a copy of all correspondence, telegrams and communications of any kind relating to the vacancy of caretaker of the Government building at Amherstburg, Ontario, and the appointment by the Civil Service Commission of a successor. Also a copy of all papers and documents preceding and subsequent to the supposed appointment, and subsequent correspondence and recommendation by any one, of any other person, for the position whether under the Civil Service or another department of State.

Also,—Return to an Order of the House of the 30th April, 1928, for a Return showing:—

1. Whether the Canadian Government brings in immigrants from the British Isles and foreign countries, and supplies them with free land for settlement.

2. If not, on what terms immigrants receive such lands.

3. Whether any monetary assistance is afforded said immigrants other than land settlement inducements, and if so, what they are.

4. Whether like inducements, if any, as regards free land and other assistance, are offered to Canadians.

5. If not, why not.

And also,—Return to an Order of the House of the 14th May, 1928, for a copy of all correspondence, telegrams and other communications and documents in the possession of the Post Office Department, Civil Service Commission, and other departments since the 1st day of January, 1924, relating to the post-mastership and post office at Sutton, Quebec.

And also,—Return to an Order of the House of the 16th May, 1928, for a copy of all correspondence, reports, memoranda, advertisements, decisions, ratings and other documents in possession of the Civil Service Commission and the Post Office Department relating to the recent promotional competition to fill the position of Principal Clerk in the Ottawa City Post Office, involving the appointment and rejection of one R. E. Hall.

Mr. Elliott, a Member of the King's Privy Council, laid before the House,—Correspondence respecting public buildings in British Columbia as follows:—

Coal for Ashcroft public building; coal for Kamloops public building; public building at Salmon Arm; public building at Prince George.

Also,—List of wharves in Nova Scotia belonging to the Canadian National Railways, which it is suggested be transferred to the Department of Public Works.

And also,—Statement showing the number of admissions to Dominion quarantine stations during the fiscal year ended March 31, 1928.
