Mr. McGIBBON: We take the ground that we are not going to have hon. gentlemen opposite collect the fees while we write the prescriptions. I want to press very strongly upon the minister that this action be taken, and I do not think any member of this house will object to it. We are all human; we all know what we are here for and most of us are pretty good party people. We follow our party sometimes when we differ from it, because of the greater good to the country, but when the time comes, as we hope it will come, when this depression lifts and the treasury contains a little money, we want the needs of the people in those parts of this country which have been neglected looked after before there are any railway stations built in Témiscouata, or new wharves or anything of that kind.

Mr. STEWART (Leeds): This amount of \$16,500, of which \$9,500 is a revote—

Mr. VENIOT: Could the minister just tell me who is the inspector? I know the rest of the details.

Mr. STEWART (Leeds): The contractor is J. S. Parker; the inspector is A. Savoie, and the rate of pay is \$4 per day.
