Northern Ontario Pipe Line Corporation ber shall rise to speak after that hour, but all such questions as must be decided in order to conclude such adjourned debate or postponed consideration, shall be decided forthwith.

I have already put one question. I now propose to put the second question which is—

Mr. Fulton: Mr. Chairman, on a point of order-

Mr. Martin: Mr. Chairman, I have been paired.

Some hon. Members: He was paired in his vote.

Some hon. Members: A pair.

Mr. Martin: Mr. Chairman, I was paired with the hon. member for Cape Breton South and I inadvertently rose and voted. I would ask you to withdraw that vote because I have a pair with the hon. member for Cape Breton South.

The Chairman: I regret very much that it is impossible for me to order that the vote be withdrawn but your remarks will appear in *Hansard*.

Mr. Fulton: Mr. Chairman, on a point of order, do I understand Your Honour to rule that no hon. member can take the floor after one o'clock?

The Chairman: That is the ruling I have made.

Mr. Fulton: Mr. Chairman, on a point of order. I submit that it is not—

Some hon. Members: Sit down.

The Chairman: Order. I have already ruled that I am bound by standing order 33. I must put this question immediately.

Mr. Fulton: On a point of order, I submit-

An hon. Member: There is no point of order.

The Chairman: Order.

Mr. Fulton: I submit that Your Honour has no right—

The Chairman: The hon, member must resume his seat while I am standing.

Mr. Fulton: Mr. Chairman-

An hon. Member: Sit down.

The Chairman: The terms of the standing order are perfectly clear, that no member shall rise to speak after that hour but that all such questions as must be decided in order to conclude such adjourned debate or postponed consideration shall be decided forthwith. I have put a question and I now propose to put a second question:

 $\,$ Mr. Harris moves that I do now leave the chair and report the resolution with respect to the Northern Ontario Pipe Line Crown Corporation.

[The Chairman.]

Mr. Fulton: The minister cannot make that motion because you have already ruled that no one can speak after one o'clock. I now desire to speak to a point of order and I insist upon my right to speak.

An hon. Member: Sit down.

The Chairman: Order. The hon member will kindly resume his seat while—

Mr. Fulton: I insist upon my right to speak to the point of order.

Some hon. Members: Order.

The Chairman: Order.

Mr. Fleming: Another gag.

Mr. Drew: Another form of closure.

Mr. Rowe: Can a member not speak to a point of order?

The Chairman: I have already expressed myself on three occasions. I think the standing order is perfectly clear, and I read again from the standing order:

...but all such questions as must be decided in order to conclude such adjourned debate or postponed consideration, shall be decided forthwith.

It is not a question of one member or another speaking after one o'clock, it is a question of deciding those matters which must be concluded in accordance with the standing order. I propose to put the question immediately.

Mr. Fulton: I protest; I demand the right to speak on a point of order.

An hon. Member: Sit down.

The Chairman: Order.

Mr. Fulton: I am not to be bulldozed by the Chairman as this house is being bulldozed by the government. If Your Honour will look at the record of past years he will see that many points of order have been raised at the stage at which I am raising this one. I demand the right to be heard.

The Chairman: If necessary I shall direct the hon, member to resume his seat.

Mr. Fulton: You may do so, but I refuse to be bulldozed.

The Chairman: I direct the hon. member to resume his seat.

Mr. Fulton: I submit—

The Chairman: If the hon, member will not resume his seat I must report the matter to Mr. Speaker.

Mr. Fulton: I will make one more endeavour—

Some hon. Members: Order.
