the newly announced inquiry into the cost of [Translation] farm machinery will include any examination of the problem of so-called tied sales in this industry, a problem which I raised in this house on March 31 in a question to the Minister of Justice?

Hon. J. J. Greene (Minister of Agriculture): Mr. Speaker, I believe the terms of reference of the inquiry are sufficiently broad to cover all aspects of farm machinery costs, but I will bring this particular question to the attention of the commissioner.

PURCHASE BY RAILWAYS OF NEW TYPE HOPPER CARS

INDIA-REQUEST THAT FURTHER AID BE GIVEN

Mr. W. B. Nesbitt (Oxford): Mr. Speaker, I should like to direct a question to the Secretary of State for External Affairs. Is the government giving consideration to providing the government of India with additional gifts of wheat to alleviate the famine conditions existing in that country at the present time?

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, my hon. friend will recall that we have already provided assistance to India to meet her very regrettably serious food situation, in the amount of some \$75 million for this year. The high commissioner has acknowledged this, as has Mr. Ashoka Mehta, the Indian minister for planning.

Mr. Nesbitt: A supplementary question, Mr. Speaker. In view of the fact that a large portion of the gift just mentioned by the minister is a forgiveness of loans and interest thereon, is the government considering giving additional gifts of wheat, which is something the people can eat?

Mr. Martin (Essex East): My hon. friend, of course, is wrong in his facts. There was a concellation of an indebtedness of some \$10 million this year. The \$75 million represents a net amount.
