EFFECT OF UNITED STATES ECONOMIC MEASURES— DISCUSSION WITH WASHINGTON OF OPTIONS AVAILABLE TO CANADA

Mr. Frank Howard (Skeena): May I direct a supplementary question to the Prime Minister, Mr. Speaker. On either of the two missions to Washington by ministers and government officials or in any subsequent conversations dealing with the effects of United States economic measures, was there any discussion about the options that might be available to Canada and which might be taken? Was that the subject of any conversations with the government of the United States?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the question is not very clear to me. I am not aware of the nature of the options which the hon. member is suggesting might have been offered to Canada. What type of options has the hon. member in mind?

Mr. Howard (Skeena): Let me try in a supplementary way to enlighten the Prime Minister. During either of the two missions or in communications since that time were the subject matter or contents of Bill C-262 discussed with officials of the United States to determine whether or not this would be acceptable to them inasmuch as the government likes to know what the government of the United States thinks about what it plans to do?

Mr. Trudeau: Mr. Speaker, the answer is no, not only to the question but to the innuendo.
