- 2. Of the applications received, how many were approved and what is the amount of the loan in each case?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by the Farm Credit Corporation and the Department of Finance as follows: 1. (a) Thirty-two applications. (b), (c), and (d) Data is not available concerning the number of applications received by chartered banks and other lenders under these three Acts.
- 2. (a) Twenty-two approvals in the amount of \$542,500 and six applications are under consideration.

NOTE: The Farm Credit Act (SC 1959, c. 43, proclaimed on October 5, 1959) established the Farm Credit Corporation as successor to the Canadian Farm Loan Board established in 1929. The Corporation, which is a Crown agency, reports to Parliament through the Minister of Agriculture.

During the 1971 vacation period for students the Department of Manpower and Immigration operated Canada Manpower Centres for Students as follows: (a) in Canada a total of 119; (b) in Nova Scotia, 4; New Brunswick, 4; Prince Edward Island, 1; Newfoundland, 1; Quebec, 43. (N.B.: The Canada Manpower Centre for Students at 239 Queen Street, Ottawa, was set up to serve all students in the Ottawa-Hull area so that, in effect, there were 44 points of service for students in the province of Quebec.) Ontario, 56; Manitoba, 2; Saskatchewan, 2; Alberta, 3; British Columbia 3. (N.B.: The Canada Manpower Centre for Students at 729 West Hastings Street, Vancouver operates year round.)
