I have to bear in mind not only the importance of the subject but the desirability of getting round to as many other hon. members as possible. As I say, individual members may never be entirely happy about the way in which this discretion is exercised, but the Chair must decide and it can never, in my view, constitute a question of privilege.

Mr. Stevens: My question of privilege is that I put this serious question to the Prime Minister—

Some hon. Members: Sit down!

Some hon. Members: Order!

## CANADIAN BROADCASTING CORPORATION

ALLIANCE FOR LIFE GROUP BE INVITED TO APPEAR ON NETWORK
