Oral Ouestions

SCIENTIFIC RESEARCH TAX CREDIT—KITCHENER MINI-SUBMARINE SCHEME

Since the Conservative Government's moratorium on the Scientific Research Tax Credit scam a further \$1.5 billion to \$2 billion has been lost to the Public Treasury.
