Oral Questions

In the memo that the U.S. lobby sent out that I referred to yesterday, and the Minister acknowledged yesterday in the House that she had read, in talking about the legislation and in collaborating with the Government, this group of American lobbyists in Canada say: "This would assist the Prime Minister with respect to the sovereignty issue in the free trade debate, the Canada-U.S. relationship issue, and the over-all question of his leadership".

Does the Prime Minister think that his Government ought to be so intimately connected to a U.S. pressure group that sees itself as aiding in his re-election?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I think the weakness of the position of my hon. friend was in the preface to his question where he quoted an unidentified official who, he says, was "alleged to have said". That is the preface or the premise of the hon. gentleman's question. The preface is, of course, fragile and misleading, and the conclusion is false.

We will see who needs whom in an election campaign. We will stand on our policies and with our candidates, as I am sure my hon. friend will. But I think my hon. friend has more to do than raise unsubstantiated allegations from anonymous and unidentified people. If he has a complaint or a statement to make, let him make it to an attributed spokesman, and then we will deal with it.

GOVERNMENT POSITION

Hon. Edward Broadbent (Oshawa): Mr. Speaker, I sincerely wish the Prime Minister would listen to the whole question and not just the preamble.

Some Hon. Members: Oh, oh!

Mr. Broadbent: It may be funny to the Prime Minister, but in my question I was quoting from a document that the Minister has. I will quote the words again, and I ask the Prime Minister to respond. This is a document prepared by a U.S. film lobby in Canada. They say they are supporting the proposed legislation because it will aid the Prime Minister in his leadership, and it will further their interests in getting the trade deal accepted.

My question to the Prime Minister is the following. Forget the alleged official, deal with the issue that the Minister has, which is a document. Does the Prime Minister of Canada believe the Conservative Party ought to be actively collaborating with the U.S. pressure group that is working against the Canadian film industry for its own political gain? That is the question.

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I cannot comment on a document that comes from a third party or a lobby somewhere for which I am not responsible. I believe that that document was the one that was brought to the attention of the Minister yesterday, and the

Minister indicated that it was inaccurate and misleading. That is my information.
