The Acting Speaker (Mr. Paproski): I have the honour to inform the House that a message has been received from the Senate informing this House that the Senate has passed the following bills without amendment: Bill C-3, an act respecting the acquisition, administration and disposition of real property by the Government of Canada; Bill C-18, an act to amend the Income Tax Act, the Canada Pension Plan, the Cultural Property Export and Import Act, the Income Tax Conventions Interpretation Act, the Tax Court of Canada Act, the Unemployment Insurance Act, the Canada-Newfoundland Atlantic Accord Implementation Act, the Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act and certain related acts; Bill C-20, an act to amend certain statutes to amend the budget tabled in Parliament on February 26, 1991; and Bill C-38, an act to provide for the continuance of Telesat Canada under the Canada Business Corporations Act and for the disposal of shares therein of Her Majesty in the right of Canada.

I have the honour to inform the House that a message has been received from the Senate informing this House that the Senate has passed Bill C-47, an act for granting Her Majesty certain sums of money for the Public Service of Canada for the financial year ending March 31, 1992.
